Eligibility and Specifications:

PARTICIPANTS: The competition is open to artists, 21 years or older, living in Indiana, Illinois, Michigan, Ohio & Wisconsin.

ARTWORK: Prints and drawings on paper must be original art, conceived and executed solely by the artist within the last two years, without instructional assistance. Photography excluded. All work that is for sale will be subject to a 35% commission which will benefit the Lubeznik Center. Artwork that has won a previous award within the 5 specified states may NOT be entered into this competition.

SIZE LIMITATIONS: Size is limited to 130" total, per piece. 2-D works: measure length + width, 3-D works: measure girth + height.

Notification:

Entrants will be notified by mail of acceptance/rejection by August 14.

Sales and Reproduction:

Sales are encouraged with a 35% commission benefiting the Lubeznik Center. As a condition of entry, the artist grants the Lubeznik Center permission to reproduce entered images for publicity and education.

Entry Procedure:

ESTABLISH YOUR PIN#: This number will be associated with you and/or your entries throughout the duration of the show. The purpose is to maintain anonymity in the jury process. In the unlikely case there is a duplication, The Lubeznik Center will assign a new PIN# for you. We suggest using the last 4 digits of your phone number or driver's license number.

- Judging will be based on electronic files. No slides or photographs will be accepted.
- Each artist may enter up to 3 pieces of artwork. Artists should submit 1 image for each 2-D piece and two images for each 3-D piece.
- Images must be oriented with top of artwork appearing at top of screen.
- For jury reference, include PIN#, dimension & medium on image.
- Images provided as JPEG, sized 1920x1920 pixels at a minimum of 72 ppi, readable by both Mac & PC formats. No application file formats accepted.
- Files must be submitted on CD. E-mailed files will not be accepted.
- Electronically title the image files with the PIN# ONLY (including the hyphenated number at the end of the specific entry). For Example, assuming your PIN# is 1234, your 1st entry would be titled "1234-1".
Do not use the title of the work or your name in the filename.
- Label the outside top of the CD with artist's name.
- CDs will not be returned, please keep a copy for your records.
- Delivered artwork not representative of accepted images will be disqualified.
- We process payment for all submissions.

SEND THE FOLLOWING ITEMS:

- Completed & signed entry form;
- Payment or credit card information - Entry fee is \$35 (LCA members \$30). Fee non-refundable;
- 1 disc, including images for 1 to 3 entries;
- Self addressed and stamped #10 envelope, for notification, to the Lubeznik Center for the Arts at 101 W. 2nd St., Michigan City, IN 46360. Must arrive July 1, 2009 no later than 5 pm.

Liability:

Standard fine arts insurance coverage will be provided for accepted works from delivery through pick-up.

Delivery of Accepted Artwork:

Work accepted into the Regional Juried Art Exhibition may be either hand delivered or shipped to the Lubeznik Center for the Arts, 101 W. 2nd St., Michigan City, IN, from Oct. 2 - Oct. 9 during regular business hours. Shipped artwork must be in reusable containers, insured and have return shipping costs pre-paid - No Exceptions. Make sure the container is sturdy and its contents are well packed. Shipped work arriving damaged will not be exhibited or repaired. Accepted works may not be withdrawn prior to the closing of the exhibition. All work must be ready to hang, properly wired & assembled.

Opening Reception:

All entering artists are invited to attend and bring guests to the opening reception on October 17, 2009, from 7-9 pm (Chicago time) at the Lubeznik Center for the Arts. The awards presentation will begin at 8 pm.

Pick Up:

Work must be picked up from January 10, after 4 pm, through January 17 during regular hours. Works unclaimed by January 22 will be disposed.

Labeling of Accepted Artwork:

Labels (below) must be affixed to the upper left hand corner of back side of the work for 2-D artwork and to the bottom of the base for 3-D artwork. Labels may be duplicated. Should an entry contain multiple parts, indicate "1 of 2", "2 of 2", etc. on top right corner of the label.
